Here is the status of the evidence obtained from you on 1 Jan 2004.

There are no other CID Report of Investigations (ROI) pertaining to you.

The ROI number 81133 was erroneously placed on the documents in the file and was corrected at the time of the final report.

The only ROI number associated with you is 81132.

The only other references to your name in CID files are Raw Data Files pertaining to the previous contact with you in March 2011 for the amendment request to the investigation.

The other Raw Data File entry was from Germany when the CID office there documented all the Military Police Blotters. You were apprehended by the Military Police under MPR00743-2004-MPC0547 for drunk and disorderly.

As for the location of evidence. When the final report reflects:

It is referring to the CID office in Arifjan, where the report originated. Not at Ft Belvoir or anywhere else.

Mr. [REDACTED],

I left you a voicemail, and you did not call me back. I looked for an email and there is nothing from you. What is going on? Usually when its this quiet, my gut tells me something is going on behind closed doors.

I am very paranoid, and though you seem trustful, you are agent; these are your buddies. If I am right, then they are in a lot trouble. Plus, it backs my theory that agents have been throwing kits away, and filing them under "fake" ROI numbers. I don't want to question your ethics, principles. I am just not sure why it takes so long to find the status of evidence? Today is Thursday, the 15th of November 2012; you found out about "evidence" on Tuesday the 13th. Why so long? I understand the system was down; but the phone works, email works, the man oh yes Director I hope he still works. So, why so long?

Why does CID have cases on me from 2010, 2011? I was told by an agent that he could not see, because "It was too high up for him too see". You can be rest assured that I have been in touch with my Congressman and he is aware of this. His office will be requesting those records, and yes I will repeal the privacy because I want to know who in the hell thought that they had the right to open something against me, without my knowledge. Take that to the Feds if you wish; I am not afraid anymore.

There are too many "accidents"; 1st one is in the evidence/ custody documents. 2nd is when the VA rated my case. You see they were given investigation 81132. I know this because SA [REDACTED] in his Agent Note; stated that when he spoke to Captain [REDACTED] she said that I looked normal for the trauma I suffered. But on [REDACTED] he spoke to her first and said that I did suffer. Department of Veterans Affairs, in their statement of the case against me stated that Dr. [REDACTED] stated that I "looked normal for someone to experience that type of

trauma". She saw the evidence, your agents, lied, cooked the books, messed with evidence. 81132 had no evidence, no photos, no statements for my attacker. Congressman Lankford requested everything from Muskogee that they have for claims. Guess what dude... not one damn statement from my attacker, not one picture, not anything that shows RAPE.

It paints a picture of a whore, that took her clothes off, and put on a show for the men in that tent. It shows that she did not want to get in trouble, so she made a claim of rape it, to clear her. What in the hell is that?

All the statements were "stacked" against me. 3rd. is a letter from the undersecretary under the direction of then President George Bush that sent me to war.. who said and I quote, "one of the reason you were discharged was because the statements you made were proven to be false., Yet we are back looking at evidence, no Rape kit, no photos, no nothing. Then moving forward, we have the correction of the record. General Colleen states that evidence is in the dispensary in Ft. Belovior, then should have been moved to where you guys are now. Yet before that [REDACTED] states to me that my evidence was never tested, because "CID" felt, that it was consensual, so it was destroyed. Which the law tells me that whoever did that, broke the law. 1985 governed my case. The evidence proved force, injury, great bodily injury but it was destroyed. Did it ever occur to those agents that he knows who the other attacker was? That a deal could have been made? Well of course not, just a female... Then lets see here, then we have all these numbers running around. [REDACTED] states no that is wrong you should ask for 81132. Well why? Command used 81133 to get rid of me. All this mess.

You got agents, that are liars, dishonest. Costing the government tons of money by chaptering them out, For no apparent reason. These victims are real, they are homeless, with no healthcare, no job, and commits suicide at high rates. When I finally figured this out it Pissed me off.... Case after case, after case goes for trial, not enough evidence, rape kits gone, females and males complaining about more than one report number. A Chief of Staff that I know as also told me of other rape victims that have spoken of multiple ROI's. Rape kits from my contact tells me that they should be tested in GA. Blood goes to DC... yet they are sitting in Kuwait, Afgan or Laudstual? What kind of crap is that? You guys cant get justice for us, because of the ROGUE, unethical agents you havc; Like [REDACTED] [REDACTED]r, and whoever else. The icing on the cake, was a letter from the Department of the Army saying that the only evidence they have, shows no blast, no rape, just "bad" things in my file. My personal file. Are you awake yet? You guys have [REDACTED] as a Major, still and [REDACTED] is a SSGT, so two in leadership. Are you comfortable with this? How many rapes has [REDACTED] covered up for him? How many has he done, because CID in Kuwait let him get away with it? Are you prepared to handle the downdraft and micro bursts from that, when it blows up in your face?

Let me give you another picture. I have always wanted to be pleasing, a people pleaser. If someone called me a name, like a liar for example. I wanted to show that I was not. I have been this was my whole life. I don't know why. The first time I was arrested for lying, I was devastated. I had a hard time remembering, and I tried and cried alot. I remembering laying on my bunk looking at the camera; I saw [REDACTED] and wanted to prove to [REDACTED] that I was not lying. That is why I took it to him. I did not want him to think that I was a liar. I looked at the ROI again last night and discovered something else. After I gave him the photo, they found out who [REDACTED] was, [REDACTED] was questioned, and on the way to collect evidence.. here comes [REDACTED] with statements. [REDACTED] took them, that by UCMJ wiped out every charge, yet Liar is still there. So, he is on his way to get evidence, and a commander stops to give him statements... Think about that. I also looked at the drawing that was done. [REDACTED] area was

on the other side of that tent. I would do anything I had to to prove it. I will never forget it; that picture is still so very fresh in my mind. I dont know if they moved it around. But, it was on the otherside... then after [REDACTED] does that.. he calls for me and arrests me again.

Sometimes, I wish..... well never mind....

I need to know the dispoition of that evidence. If I need to fly, then I can fly. Let me know.
