Understand you called a couple of times yesterday, but did not/would not leave a number for me to return your call.

To update you from when we last spoke, I wanted to relay two pieces of information:

1. No criminal charge was filed against you in violation of Article 107 (Providing/Making a False Official Statement). This was disposed of under non-judicial punishment, and so there is no criminal record to expunge and/or correct.
2. You may submit a request to obtain a copy of the hearing conducted to review the disposition of your file from the ABCMR. Additionally, you may seek a copy from the VA. As I previously indicated to you, criminal law and investigations are not my area(s) of expertise, and I apologize for mistakenly pointing you in the direction of USACIDC.
